**Re: Set Fines – Provincial Offences Act – Part I**  
**Township of Val Rita-Harty, Cochrane District**

Thank you for your letter dated December 14, 2015 directed to Kerry-Lee Thompson regarding a set fine for By-Law #1013-15.

I have had an opportunity to consider your request. For the reasons that follow, I have not approved the request and have instead imposed a set fine of \$175.00 for these offences.

A set fine is a sentencing process and must consider the circumstances of the offence, the need for deterrence and must also consider proportionality (minor versus serious offences). Early guilty pleas are also an important consideration.

The set fine regime is meant to encourage out of court settlements, while also considering the above principles and must also consider similar sentences for similar offences in the region. I have reviewed other such by-laws in the region. The average set fine is well below \$200.00. I have also considered rural versus urban in this review.

Setting the set fine in this case at the amount requested would neither achieve the ends of sentencing nor the set fine regime.

The setting of the fines does not constitute my approval of the short form of wording used to describe the offences.

# CORPORATION OF THE TOWNSHIP OF VAL RITA-HARTY

BY-LAW No. 1013-15

## **BEING A BY-LAW TO PROHIBIT THE OBSTRUCTION OF ROADWAYS AND SIDEWALKS WITHIN THE MUNICIPALITY OF THE VAL RITA-HARTY AND REGULATE THE DUMPING OF SNOW THEREON**

**WHEREAS**, Section 8 of the Municipal Act, Chapter 25, S.O. 2001, as amended, confers broad authority upon municipalities and provides that a municipal power shall be exercised by by-law;

**AND WHEREAS**, the Highway Traffic Act (R.S.O. 1990, C. H.8, S. 181) prohibits any person from depositing snow or ice on a roadway without permission from the road authority, and

**NOW THEREFORE** the Municipal Council of the Corporation of the Township of Val Rita-Harty enacts as follows:

1. For the purpose of this by-law, "roadway" shall be defined as the municipal road allowance and "travelled portion of the roadway" shall be defined as that part of a roadway designated or intended for use by vehicular traffic.
2. No person shall place or deposit, or cause to be placed or deposited, snow on the travelled portion of a roadway within the Municipality of Val Rita-Harty.
3. No person shall create or cause an accumulation of snow to be created on property adjacent to municipal sidewalks or roadways, thereby causing the obstructing, encumbering or fouling of such sidewalks or roadways.
4. No person shall deposit any snow from a private property or cause any snow from a private property to be deposited on any part of a roadway allowance within the Municipality of Val Rita-Harty.
5. The accumulation of snow on the part of a municipal road allowance that is located along the entrance or driveway of a private property may be cleared and deposited by the owner of the property only on the part of the road allowance that fronts his property and that is not open for and used by or for pedestrian and vehicular traffic and parking.
6. No property owner, tenant, occupant or contractor shall deposit snow on or fronting his property on any part of a roadway allowance that is located adjacent to any other neighboring property.
7. Every person who contravenes any section of this by-law is guilty of an offence and upon conviction of an offence is liable to a fine as provided for by the Provincial Offences Act R.S.O. 1990 Chapter P.33 as amended, and all the provisions of the said Act shall apply to any prosecution for any offence under the provisions of this by-law.


