

# CORPORATION OF THE TOWNSHIP OF VAL RITA-HARTY

BY-LAW No. 996-15

BEING A BY-LAW to regulate loads of commercial motor vehicles and trailers on certain highways and streets within the jurisdiction of the Corporation of the Township of Val Rita - Harty during a specified period of time

AND WHEREAS *the Highway Traffic Act*, R.S.O. 1990, Chapter H.8, section 27, provides that Council of a Municipality may by By-Law restrict commercial vehicles and trailers to half loads during any period of the year and provide a penalty for operators of such vehicles who contravene the provisions of this By-Law and trailers for certain periods of time on certain highways

AND WHEREAS Council considers it desirable to restrict use of commercial, motor vehicles and trailers year round on certain highway in the Corporation of the Township of Val Rita - Harty

NOW THEREFORE the Council of the Corporation of the Township of Val Rita - Harty enacts the following By-Law


1. The operation of commercial vehicles or tractors by any person is restricted to half load limits from April 1<sup>st</sup> to December 1<sup>st</sup> inclusively of each year on Cargill Road from it's intersection with King's Highway #11 and the roadway dividing Concessions 12 and 13 in the Township of Owens.
2. Every operator of commercial motor vehicles and trailers, other than public vehicles operated over or upon any portion of the Highway named in section 1 to this By-Law are subject to the provisions of Section 122 of *the Highway Traffic Act*, R.S.O. 1990, Chapter H-8.
3. (1) Every person who contravenes any provision of this By-Law established and passed by the Corporation of the Township of Val Rita - Harty pursuant to the authority contained in the Municipal Act or any other general or specific Act is guilty of an offence, *the Municipal Act* S.O. 2001 c. 25 subsection 425(1).  
  
(2) Every person who is convicted of an offence is liable to a penalty as provided for in *the Highway Traffic Act* R.S.O. 1990 Chapter H-8, Section 125, as amended, and all the provisions of the said Act shall apply to any prosecution for any offence under the provisions of this By-Law.
